
Purpose and Methodology

- Purpose: Better understand and explore opportunities to possibly collaborate and build closer ties with like-minded PHAs.
- ► Hypotheses:
 - There are a small number of high-performing PHAs around the country that are innovative and collaborative in their community development approach and impact (Hybrid PHAs).
 - ▶ These PHAs might be a good fit for a deeper connection with HPN.
 - ▶ There is mutual interest by hybrid PHAs and HPN in exploring deeper opportunity for connection.


Methodology:

- Understand the "DNA" of HPN via conversations with members, HPN staff, Exchange Committee, a site visit to HPN's Boston office and attendance at the June 6-8 Membership Meeting
- Phone interviews with eight PHA CEOs (Austin, Denver, Houston, Home Forward (Portland, OR), King County (WA), San Antonio, San Diego, Seattle)
- Discussions with industry leaders and PHA consultants & literature review
- Review and feedback by HPN's Exchange Committee

Themes from HPN Interviews

Overlap with PHAs

- Co-developers, responding to RAD RFPs
- Project-based Section 8 vouchers
- Recipient of public dollars administered by the PHA
- Competition for LIHTC or other financing, ROSS grants
- Service partners
- Serve on regional/state policy boards and committees

Interest in PHAs

- Value in a wider voice and geographic diversity
- Our members could learn from how PHAs have adapted
- "We could bring ideas back to our PHA"
- Almost every HPN staff or member interviewed could easily list 3-5 PHAs that they saw as innovative, entrepreneurial, etc.

Questions/Concerns

- Impact on the HPN brand?
 "We're not them" mentality
- Questions and discomfort over competition, regulatory relationship and power differential – would it impede open communication?
- Impact on policy relationships?
- What would success look like?

Themes from PHA CEO Interviews

Overlap with HPN Members

- Work across public and private sectors, mixed income, mixed use
- Development expertise mix of self- and JV
- See their work as entrepreneurial and transformative
- Boards govern autonomously and in the best interest of the agency
- Longevity of executives

Interest in HPN

- Development discussions not through a HUD lens
- Exposure to financing tools
- Learning new approaches to common areas of interest (homelessness, supportive services, housing preservation, cross-sector work, etc.)
- Would be a both-and to CLPHA, NAHRO membership
- Expanding networks

Questions/Concerns

- Would the networks and learning outweigh the time commitment?
- How would this impact policy relationships?
- What would success look like?

Opportunities for Intersection

- 2. What would success look like if HPN expands its reach to include PHAs? And over what timeframe?
- 3. Are the differences really that different?
- 4. If HPN moves forward, what criteria will be used to vet and select PHAs?
- 5. What messages will HPN's Board use to **communicate its decision** and to which audiences?
- 6. Would anything in the HPN DNA change if the Board decides to move in a more intentional direction with entrepreneurial, forward-thinking PHAs?
